ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-14577

WATER DIVISION 1-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-14577 is held by Glendon F. Luthy.
2. The Department has received information that Glendon F. Luthy is deceased.
3. A search of the records of the Richardson County Register of Deeds indicates the land appurtenant to appropriation A-14577 includes names of owners that are different than the owner listed in the Department records. These individuals are Glendon R. Luthy, Gertrude L. Spearman, Lois Luthy and Kevin J. Spearman.
4. Appropriation A-14577 has a priority date of December 7, 1976, and authorizes the use of water for irrigation of the 231.5 acres of land described below. The water may be diverted from the South Fork of the Big Nemaha River at points of diversion located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35 and the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 36, both in Township 2 North, Range 13 East of the 6th P.M. in Richardson County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 3.31 cfs from both points of diversion.


