ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-14911

CASE NUMBER 2014-33-PD-1

WATER DIVISION 1-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-14911 is held by Brooklet Stock Farm, A Limited Partnership.
2. Appropriation A-14911 with a priority date of April 18, 1977, authorizes the use of water for irrigation of the 58.5 acres of land described below. The water may be diverted from a tributary to Weeping Water Creek at a point of diversion located on the left bank of the stream in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 33, Township 11 North, Range 13 East of the 6th P.M. in Cass County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.84 cfs.

3. The Department has received information concerning the use of surface water appropriation A-14911 that indicates the appropriation has not been used for its required purpose for more than five consecutive years.
4. On September 12, 2014, the Department issued a Notice of Preliminary Determination of Nonuse of appropriation A-14911. The Notice was delivered by certified mail to Brooklet Stock Farm, A Limited Partnership, c/o William Schlichtemeier, 2018 South 151st Street, Omaha, Nebraska 68144.
5. No contest of the Preliminary Determination of Nonuse was received in the Department.
6. The Department has determined that appropriation A-14911 has not been used for its required purpose for more than five consecutive years.


7. *Nebraska Revised Statutes* § 46-229.02 provides that an appropriation not used for a beneficial purpose for more than five consecutive years may be cancelled.
