APPROVAL OF MAP 18957 FOR WATER APPROPRIATION A-19229

BACKGROUND

1. On April 8, 2014, Lawrence S. Ourecky, on behalf of the Lawrence S. Ourecky Revocable Living Trust, and Lisa Emeigh, on behalf of the Ruth L. Ourecky Revocable Living Trust, filed in the Department of Natural Resources (Department) application A-19229 for a Permit to Appropriate Water.
2. On July 9, 2014, Lawrence S. Ourecky, on behalf of the Lawrence S. Ourecky Revocable Living Trust, filed in the Department map number 18957 showing land proposed to be irrigated under application A-19229.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18957 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19229 as depicted on map number 18957:

4. The appropriator is bound by all terms and conditions of the approval of application A-19229.
