APPROVAL OF PETITION RLP-5563 AND MAP 19454 TO CHANGE THE LOCATION OF
DIVERSION FOR WATER APPROPRIATION A-8523

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-8523 is held by Charles M. and Linda L. Pohlman.
2. Appropriation A-8523 has a priority date of April 28, 1956, and authorizes the use of water for irrigation of 43.5 acres of land. The water may be diverted from the North Fork of the Elkhorn River at a point of diversion located on the right bank of the stream in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 28, Township 25 North, Range 01 West of the 6th P.M. in Pierce County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 140 acres irrigated at a maximum rate of 0.31 cfs.
3. On January 27, 2016, Charles M. and Linda L. Pohlman filed petition RLP-5563 in the Department for a permit to change the location of diversion for appropriation A-8523.
4. On February 12, 2016, Linda Pohlman filed map number 19454 in the Department showing the location of the proposed pump site and the land to be irrigated under appropriation A-8523 through petition RLP-5563.

ORDER

IT IS HEREBY ORDERED:

1. Petition RLP-5563 for a permit to change the location of diversion for appropriation A-8523 and map number 19454 are APPROVED.
2. Appropriation A-8523 through petition RLP-5563 is now A-8523R.

3. Appropriation A-8523R shall be shown in the Department's records authorizing the use of water to irrigate 43.5 acres of land described below and depicted on map number 19454, which is made a part of this Order. The water may be diverted from the North Fork of the Elkhorn River at a point of diversion located on the right bank of the stream in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 28, Township 25 North, Range 01 West of the 6th P.M. in Pierce County, as depicted on map number 19454. Water diverted shall not exceed the ratio of one cfs for every 140 acres irrigated at a maximum rate of 0.31 cfs (139 gallons per minute). The total volume may not exceed 3 acre-feet per irrigated acre per year.

4. All terms and conditions of appropriation A-8523 remain in effect unless specifically changed by this Order.
5. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
 - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may cause cancellation of part or all of this appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use an appropriation for more than five consecutive years may result in cancellation of the appropriation.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations.
