ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-18325B

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18325B is held by Theodore and Joan Hooker.
2. Appropriation A-18325B has a priority date of August 18, 2005, and authorizes the use of water for irrigation of the 38.4 acres of land described below. The water may be diverted from Freeman Creek at points of diversion located on both banks of the stream in the NW<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub>, NE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub>, SW<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub> and SE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub> of Section 12, Township 19 North, Range 9 West of the 6<sup>th</sup> P.M. in Greeley County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 145 acres irrigated at a maximum combined rate of 0.26 cfs from all points of diversion.


