ORDER GRANTING EXTENSION OF TIME BY PETITION EOT-2343

TO FILE MAP FOR WATER APPROPRIATION A-18823

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18823 is held by Bradley J. and Jeremy B. Mahon.
2. Appropriation A-18823 has a priority date of October 17, 2011, and authorizes the appropriator to store 15 acre-feet of water in Mahon Reservoir No. 1. The water may be diverted from a tributary to Ponca Creek at a point of diversion located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 17, Township 33 North, Range 8 West of the 6th P.M. in Knox County.
3. Pursuant to *Title 457 Neb. Admin. Code Chapter 11*, a map of reservoir was to be filed six months after the approval date of appropriation A-18823, on June 7, 2012.
4. On June 4, 2012, Bradley J. Mahon filed in the Department petition EOT-2343 requesting a three-month extension of time in which to file a map of reservoir.

ORDER

IT IS HEREBY ORDERED:

1. Petition EOT-2343 requesting a three-month extension of time is hereby GRANTED.
2. The filing deadline to file a map of reservoir under appropriation A-18823 is extended to September 7, 2012.
3. All terms and conditions of appropriation A-18823 remain in effect unless specifically changed by this Order.
