ORDER GRANTING EXTENSION OF TIME BY PETITION EOT-3499

TO FILE MAP FOR WATER APPROPRIATION A-18868

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18868 is held by Richard Wortmann.
2. Appropriation A-18868 has a priority date of January 27, 2012, and authorizes the appropriator to store 13 acre-feet of water in Wortmann Reservoir. The water may be diverted from a Beaver Creek at a point of diversion located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 11, Township 32 North, Range 2 West of the 6th P.M. in Knox County.
3. Pursuant to *Title 457 Neb. Admin. Code* Chapter 11, a map of reservoir was to be filed six months after the approval date of appropriation A-18868, on February 6, 2013.
4. On February 1, 2013, Richard Wortmann filed in the Department petition EOT-3499 requesting an extension of time until June 30, 2012, in which to file a map of reservoir.


ORDER

2. The filing deadline to file a map of reservoir under appropriation A-18868 is extended to June 30, 2013.
3. All terms and conditions of appropriation A-18868 remain in effect unless specifically changed by this Order.
