APPROVAL OF MAP 18245 FOR WATER APPROPRIATION A-18899

WATER DIVISION 2-C

BACKGROUND

1. On March 22, 2012, Evelyn A. Pierce filed in the Department of Natural Resources (Department) application A-18899 for a Permit to Appropriate Water.
2. On June 26, 2012, Philip R. Pierce, on behalf of Evelyn A. Pierce, filed in the Department map number 18245 showing land proposed to be irrigated under application A-18899.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18245 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-18899 as depicted on map number 18245 which is made a part of this Order.



3. Appropriation A-18899 has a priority date of March 22, 2012, and authorizes the appropriator the use of water for irrigation of the 40.0 acres of land described above. The water may be diverted from the Middle Branch of Verdigre Creek at a point of diversion located on the right bank of the stream in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 25, Township 30 North, Range 8 West of the 6<sup>th</sup> P.M. in Knox County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.57 cfs (256 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied.
5. The appropriator is bound by all terms and conditions of the approval of application A-18899.
