APPROVAL OF MAP 18426 FOR WATER APPROPRIATION A-19013

BACKGROUND

1. On January 24, 2013, Al Eickhoff, on behalf of L.A.H. Eickhoff Farms, Inc., filed in the Department of Natural Resources (Department) application A-19013 for a Permit to Appropriate Water.
2. On June 17, 2013, Al Eickhoff, on behalf of L.A.H. Eickhoff Farms, Inc., filed in the Department map number 18426 showing land proposed to be irrigated under application A-19013.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18426 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19013 as depicted on map number 18426:



Eickhoff EQIP Reservoir (storage appropriation A-18398) from a pump site located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 28, Township 3 North, Range 16 East of the 6th P.M. in Richardson County.
4. The appropriator is bound by all terms and conditions of the approval of application A-19013.
