APPROVAL OF MAP 18469 FOR WATER APPROPRIATION A-19017

WATER DIVISION 2-F

BACKGROUND

1. On January 25, 2013, Rod and Kay Hoelsing filed in the Department of Natural Resources (Department) application A-19017 for a Permit to Appropriate Water.
2. On April 4, 2013, Rod Hoelsing filed in the Department map number 18469 showing land proposed to be irrigated under application A-19017.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18469 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19017 as depicted on map number 18469 which is made a part of this Order.

3. Appropriation A-19017 has a priority date of January 25, 2013, and authorizes the appropriator the use of water for irrigation of the 63.9 acres of land described above. The water may be diverted from the Missouri River at a point of diversion located on the right bank of the stream in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 26, Township 32 North, Range 4 East of the 6th P.M. in Dixon County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.91 cfs (408 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied.
5. The appropriator is bound by all terms and conditions of the approval of application A-19017.
