ORDER GRANTING PETITION VAR-3491 FOR LEAVE TO FILE OR CONSIDER
AN APPLICATION FOR A NEW SURFACE WATER APPROPRIATION WITHIN
A MORATORIUM OR STAY AREA

WATER DIVISION 1-B

BACKGROUND

1. On July 14, 2004, the Department of Natural Resources (Department) issued an Order declaring a formal moratorium in the Republican River Basin on the issuance of all new surface water appropriations.
2. On January 28, 2013, Dennis Hansen, on behalf of Hansen Homestead Farms, LLC, (Petitioner) filed petition VAR-3491 in the Department for Leave to File or Consider an Application for a New Surface Water Appropriation within a Moratorium Area (Petition). The draft application and documentation attached to the petition is for a permit to impound approximately 43 acre-feet of water from a tributary to Indian Creek in the existing Hansen Homestead Pond located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 24, Township 3 North, Range 12 West of the 6th P.M. in Webster County for the purpose of water for livestock.
3. Department records of aerial photography dating back to 1993 for this location show this dam and reservoir in existence and impounding water.
4. *Nebraska Revised Statutes* § 46-714(3)(n) allows for new surface water appropriations if the Department grants leave to file an application and subsequently approves a permit for such use.
5. When filing such a petition, a project proponent must offer a clearly stated basis for such request and must offer sufficient good cause shown. *Department of Natural Resources Rules for Surface Water, Title 457 Neb. Admin. Code* Chapter 23 lists six circumstances that may be put forward as justification for granting a petition to apply for a permit to impound water, in conjunction with an examination of good cause shown.

CONCLUSIONS

1. Petitioner has shown good cause in that the impoundment has been providing the benefits of water for livestock for many years.
2. The Hansen Homestead Pond existed prior to the formal moratorium.
3. Therefore, petition VAR-3491 should be granted and the Petitioner should be allowed to file an application for a permit to impound water.


ORDER
