ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-3714

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-3714 is held by Gibbons Ranches, LLC.
2. A scrivener's error was made on the Order approving application A-3714 dated February 1, 1945. The grant was calculated using **84.2 acres**; **82.4 acres** were approved for irrigation under appropriation A-3417. Water that may be diverted is hereby corrected from **0.73** cubic foot per second (cfs) to **0.72** cfs.
3. Appropriation A-3714 has a priority date of April 17, 1944, and authorizes the use of water for irrigation of the 82.4 acres of land described below. The water may be diverted from a tributary to the Middle Loup River at a point of diversion located on the south bank of the stream in the ~~SE<sup>1</sup>4SE<sup>1</sup>4~~ of Section 10, Township 18 North, Range 17 West of the 6<sup>th</sup> P.M. in Custer County. Water diverted shall not exceed the ratio of one cfs for every 115 acres irrigated at a maximum rate of 0.72 cfs.

Gibbons Trust, Gibbons Ranches, LLC, and herself, filed a Relinquishment of Water Appropriation, REL-5584, in the office of the Department relinquishing the right to divert water under appropriation A-3714 for use upon the land described above.
