ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-18340

WATER DIVISION 2-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18340 is held by Daryll B. and Tamara L. Lightner.
2. Appropriation A-18340 has a priority date of September 8, 2005, and authorizes the use of water for irrigation of the 215 acres of land described below. The water may be released from Lightner Reservoir No. 2 (storage appropriation A-18339) located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 12, Township 31 North, Range 8 West of the 6th P.M. in Knox County. Water diverted shall not exceed 39.2 acre-feet per year.


