ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-18342

WATER DIVISION 2-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18342 is held by Daryll B. and Tamara L. Lightner.
2. Appropriation A-18342 has a priority date of September 8, 2005, and authorizes the use of water for irrigation of the 215 acres of land described below. The water may be released from Lightner Reservoir No. 3 (storage appropriations A-18341 and A-18779) located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 11, Township 31 North, Range 8 West of the 6th P.M. in Knox County. Water will travel down Soldier Creek into Lightner Reservoir No. 2 (A-18339) where it will be pumped within a 24-hour period from the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 12, Township 31 North, Range 8 West of the 6th P.M. in Knox County. Water diverted shall not exceed 8.6 acre-feet per year.

4. Daryll B. and Tamara L. Lightner filed a Relinquishment of Water Appropriation, REL-2243, in the office of the Department relinquishing the right to divert water under appropriation A-18342 for use upon the land described above.
